

ORDINANCE NO. 17 – _____

BE IT ORDAINED by the City Council of the City of Huntsville, Alabama, that Budget Ordinance No. 16-659, adopted and approved on September 22, 2016, is hereby amended for changes in the authorized personnel strength of the various departments, as follows:

In the City Council department, delete one (1) Secretary II, Grade 10 position.

In the Clerk-Treasurer department, delete one (1) Revenue License Inspector, Grade 15 position.

In the Finance department, delete one (1) Payroll Assistant, Grade 11 position and add one (1) Accountant IV, Grade 17 position.

In the General Services department, delete two (2) Building Custodian, Grade 5 positions.

In the Fleet department, delete one (1) Highway Equipment Technician, Grade 13 position and add one (1) Equipment Technician II, Grade 13 position.

In the Police department, delete one (1) Police Support Special Employee, add one (1) Alarm Coordinator, Grade 15 position, add one (1) Police Communications Manager, Grade 14 position, add two (2) Public Safety Dispatcher, Grade 11 positions, add five (5) Police Office Cadet, Grade 14 positions, add twenty eight (28) Police Officer, Grade 14 positions, add one (1) Police Lieutenant, Grade 17 position, and add one (1) Police Captain, Grade 19 position.

In the Fire & Rescue department, delete one (1) Public Safety Dispatcher, Grade 11 position and delete two (2) Firefighter, Grade 13 positions.

In the Municipal Court department, add one (1) Court Clerk II, Grade 10 position, add two (2) Municipal Court Marshal, Grade 11 positions, and add one (1) Municipal Court Judge, Grade 23 position.

In the Animal Services department, add one (1) Animal Services Officer, Grade 11 position.

In the Landscape department, delete one (1) Office Services Supervisor, Grade 12 position, delete one (1) Green Team Project Specialist position, delete one (1) Equipment Operator II, Grade 8 position, delete one (1) Horticultural Operations Supervisor, Grade 15 position, delete one (1) Landscape Management Analyst, Grade 15 position, add one (1) Equipment Operator III, Grade 10 position, add one (1) Litter Technician, Grade 9 position, and add one (1) Landscape Project Supervisor, Grade 13 position.

In the Parking department, delete two (2) Temporary, Part- Time Public Services Worker, Grade 5 positions.

In the Public Works department, delete two (2) Public Services Worker, Grade 5 positions, delete one (1) Equipment Operator II, Grade 8 position, and delete one (1) Street Sweeper Operator, Grade 9 position.

In the Community Development department, delete one (1) Secretary II, Grade 10 position and delete one (1) Accountant III, Grade 16 position.

In the Engineering department, delete one (1) General Clerk II, Grade 5 position, delete one (1) Civil Engineer I, Grade 17 position, and delete one (1) Deputy Director of City Engineering, Grade 20 position.

In the Inspection department, delete one (1) Special Contract Preservationist position.

In the Natural Resources department, delete one (1) Secretary II, Grade 10 position and delete two (2) Natural Resources Special Employee positions.

In the Planning department, delete one (1) Temporary Part- Time Public Services Worker, Grade 5 positions, delete one (1) GIS Analyst I, Grade 13 position, add one (1) GIS Program Specialist, Grade 17 position and add one (1) Special Contract Preservationist position.

In the Traffic Engineering department, delete one (1) Traffic Engineering Special Employee position, delete one (1) Deputy Director of Traffic Engineering, Grade 20 position, and delete two (2) Temporary Part- Time Public Services Worker, Grade 5 positions.

In the WPC department, delete two (2) Public Services Skilled Worker, Grade 7 positions, delete two (2) Sewer Maintenance Repair Worker, Grade 7 positions, delete three (3) Water Pollution Control Operator II, Grade 11 positions, delete five (5) Water Pollution Control Chief Operator, Grade 15 positions, add one (1) WPC Electrician II, Grade 14 position, and add one (1) WPC Mechanic II, Grade 11 position.
